Methods of payment

Annual subscriptions can be paid as follows:-

1. By cash or (preferably) by cheque/draft at our registration days - on Tuesday 11th December and Thursday 13th December 2018 at Caragh Sports Centre between 7.00pm and 8.00pm. Registration form and payment can of course be given to an athlete's coach or any club official in advance of this date. These registration dates are only for re-registration of 2018 members, it is not for new members.
2. By EFT into Naas AC bank account. Our account information is below. Please email tim.farmer1@gmail.com when the payment is made and ensure that reference is made to your name, or your child's name, in the payment. If paying by EFT you still need to ensure that the registration form (and copy of birth certificate or passport, for new members) is given to the club. **No athlete will be registered with the club or with Athletics Ireland until both the registration form and payment is received.**

2019 membership subscription rates

Our membership rates apply for the calendar year and the following are the applicable rates, approved at the club's 2018 AGM, for the year 1 January 2019 to 31 December 2019:-

Juveniles

The rate for juvenile registration is €120 for the year.

We have a discounted rate of €60 for additional juveniles in a family being registered. Anyone availing of this discounted rate must be a brother or sister of someone who is registered for 2018 at the €120 rate.

Full time third level students

We have a discounted annual rate of €100 for students in full time third level education. A copy of your college Student ID card must be presented with your membership application to avail of this rate.

Seniors

The rate for senior registration is €120 for the year.

We have a discounted annual rate of €80 for non-competing seniors.

Families

Our discounted rate for larger families is €250. This rate covers all seniors and juveniles in the family that are registering with the club. The rate is only for immediate family (ie. parents and/or children), it does not include extended family such as uncles, cousins etc.

Associates

The rate for associates is €50 for the year. This rate is for athletes registered with another AI club who are training/using Naas AC club facilities.
